2011 Ranking period: 1 June 2006 – 31 May 2010


Additionally, companies must also fulfill the following:




FASTEST GROWING 50
Ranking Methodology

- Have experienced Sales / Turnover growth of greater than 10% or higher for the last 3 years;
- Have positive Net Profit figures for each of the past 3 years;
- Companies' financials are true & fair according to the Auditors for all 4 years.

Qualified companies are then ranked based on 3-year Compounded Annual Growth Rate (CAGR), where the Top 50 are recognized.

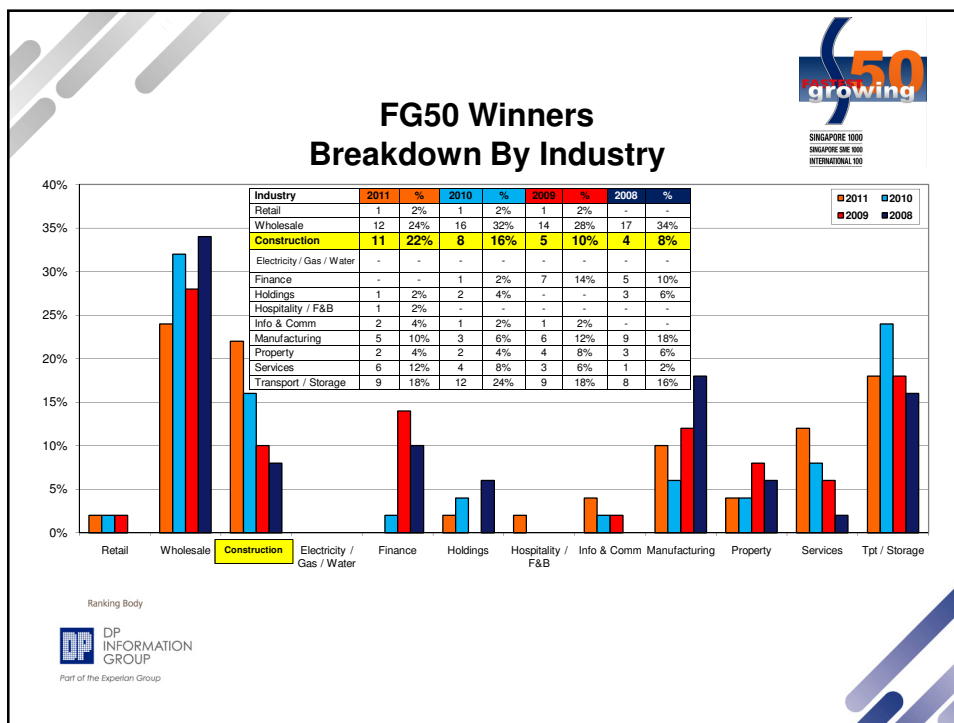
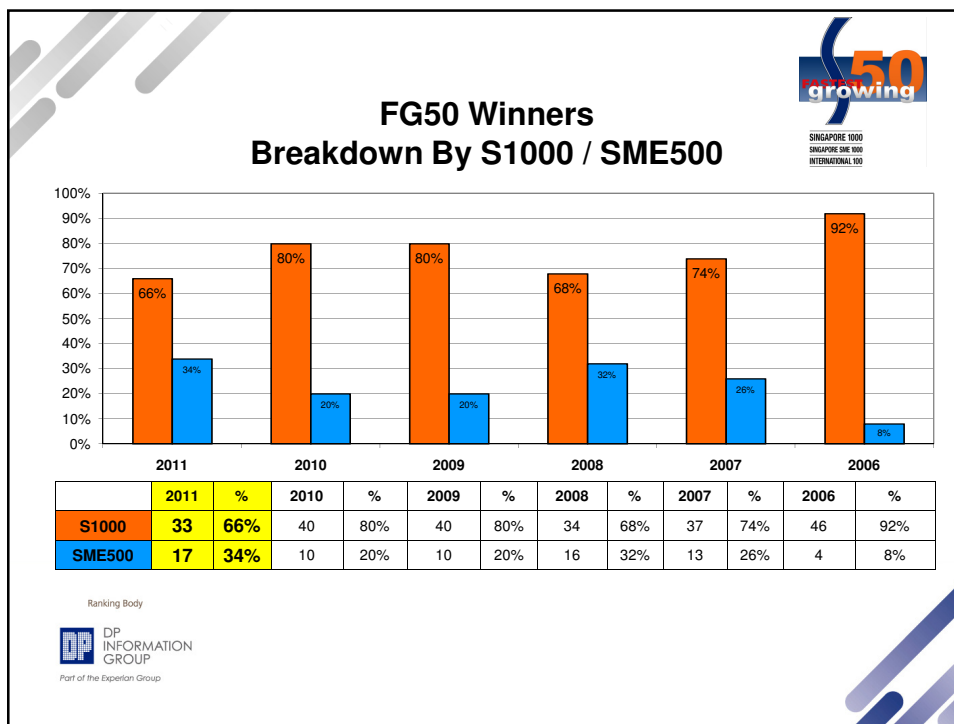

1. Be in full operation for the past 3 consecutive years to the year of certification;

2. Have experienced Sales / Turnover growth of greater than 10% or higher for the last 2 years;
3. Have positive Net Profit figures for each of the past 2 years;
4. Companies' financials are true & fair according to the Auditors for all 3 years.

Qualified companies then ranked based on 2-year Compounded Annual Growth Rate (CAGR) on OVERSEAS REVENUE, where the Top 10 are recognized.


